Feasibility Study

The Board requested that current information on the ages of septic systems around the Pelican Group of Lakes be gathered from Otter Tail County by the Lake Coordinator and Intern.

Cosgriff made a motion to Authorize the release of a RFP for a Feasibility Study of Waste Water Treatment options upon a motion of support from the PLPOA Board. Ayes all.

Board Reports

Buoys – Should be placed soon, the water levels have not been conducive.

Water Level Monitoring – The quotes received for a continuous web based water level monitoring program were discussed.

Mosquitos – The first treatment has occurred and treatments will continue as needed according to the schedule throughout the summer.

Water levels – The heavy spring precipitation and delayed ice out have contributed to record water levels and river flows. Gilsdorf made a motion to request a temporary no wake zone on the Pelican Group of Lakes through Otter Tail County. Valentine seconded. Ayes all.

Lake Coordinator Report

The water flow agreement with Cormorant Lakes Watershed District was discussed. The Board requested that the Coordinator contact Cormorant Lakes and remind them of the agreement in light of current conditions.

The Board requested that an article be drafted referring to the reasons the water levels are so high.

New Business The 2022 Election process was discussed.
